Taitamariki Development Fund

Te Pūtea Whakatupu Trust (the Trust) is proud to open for applications for the second annual Taitamariki Development Fund.

Te Pūtea Whakatupu Trust (the Trust)

The Trust was established under the Māori Fisheries Act 2004 as part of the settlement of Māori fishing rights claims. As an independent charitable trust, its role is to provide strategic leadership in education, training and workforce development for Māori, and to manage the Trust's fund made available for these purposes. The Trust has a particular obligation to ensure benefits are made available to all Māori and give regard to Māori who do not associate with their Iwi and/or do not receive benefit from a mandated Iwi organisation.

In 2018 the Trust launched its new strategy “Te Rautaki”. It has four key whāinga (goals) that set the direct investment intentions of the Trust through to 2022. The Taitamariki Development Fund (the Fund) sits under Te Whāinga Tuarua: Ngā Ako. Te Whāinga Tuarua is the second of the four key cornerstones of Te Rautaki.

Whāinga Tuarua Ngā Ako is how the Trust will work and join with partners to support education pathways for taitamariki 13 years to 35 years of age in leadership, mentoring and governance training.

This fund is purposely designed to support taitamariki Māori, young Māori between the ages 13 years and 24 years of age residing in urban areas.

Taitamariki Development Fund

The Fund's core purpose is to support taitamariki to further their educational opportunities and pursuits. These pursuits however are not prescribed by the Trust, but instead the Trust is seeking that the applicant will clearly define what their pursuits are against the categories designed by the Trust.

The Trust is very keen to support Māori taitamariki individuals or Māori organisations who are committed to supporting our Māori taitamariki. The Fund has 3 key categories that applicants can apply to:

1. Te Mātauranga Te Tuatahi
2. Te Piringa Te Tuarua
3. Te Ao Whānui Te Tuatoru

Te Mātauranga Te Tuatahi

The first category is a scholarship. This scholarship is “**Te Mātauranga Te Tuatahi**” it is designed for individual taitamariki between the ages of 13 years and 24 years of age to make application for this scholarship. The individuals must be Māori and residing in an urban setting.

The scholarship is a one off payment by the Trust to the confirmed recipient of \$2000.00 (GST INC). It is to support the individual in their educational pursuits. These pursuits must be defined by the individual directly. The applicant must be enrolled in a confirmed New Zealand educational programme or institute.

Please refer to the Taitamariki Development Fund Criteria & Application Process for further details on making application to “**Te Mātauranga Te Tautahi**” scholarship. Note that an organisation, grouping or collective are not eligible to make application for this scholarship. Nor can someone make application for, or on behalf of another person for this grant. This can only be applied by the person directly. However if the applicant is under 18 years of age their application must be also signed and supported by their parent or official care giver.

Te Piringa Te Tuarua

Te Piringa Te Tuarua is the second category of the Taitamariki Development Fund and is a grant.

The purpose of this grant is to support Māori organisations or collective of Māori organisations to design and provide positive programmes for Taitamariki in their community. The programmes are co-designed with taitamariki and must demonstrate clear outcomes of strong and resilient taitamariki at that leadership-end in Aotearoa and internationally.

This is a grant that is applicable by both individuals (Māori Taitamariki 13 years of age to 24 years of age) and or a Māori non-government agencies that are recognised as Tier 4 investment-intensive agencies by the New Zealand Treasury and based in Aotearoa New Zealand.

In brief the organisation must maintain a simple accounting format reporting and process (cash). It operates a total annual expense of less than \$125,000.00 as at the 31 December 2019. It is without public accountability. The organisation must be recognised as a Māori entity, this may include Marae. It can also be a collective of Māori individuals who have come together and meet the requirements of this category.

Te Ao Whānui Te Tuatoru

The final category for the Taitamariki Development Fund is Te Ao Whānui Te Tuatoru. The purpose of this grant is to provide Māori organisations the opportunity to create innovative services for Taitamariki whom they currently serve. This is a one off fund and the Māori organisation must be able to demonstrate previous positive delivery of services to Taitamariki.

This grant is open for application by Tier 3 and Tier 4 Māori non-government agencies that are based in Aotearoa New Zealand.

In brief the organisation must maintain a simple accounting format reporting and process (accrual). It operates a total annual expense of less than \$2,000,000.00 as at the 31 December 2019. It is without public accountability.

The applicant must be a legal entity in Aotearoa New Zealand and able to demonstrate its commitment to providing quality services to Māori taitamariki in their region or area catchment. This category is not open to individual persons.

<p>What is the Taitamariki Development Fund</p>	<p>The Fund aims to:</p> <ol style="list-style-type: none"> 1. Support taitamariki in educational pursuits 2. Engage with our taitamariki in urban area 3. Develop strong and resilient taitamariki at that leadership-end in Aotearoa and internationally.
<p>Who can apply</p>	<p>Te Mātauranga Te Tuatahi Fund Māori taitamariki in their individual capacity can apply for the Te Mātauranga Te Tuatahi grant. They must be 13 years to 24 years of age. Must reside in Aotearoa New Zealand.</p> <p>Those under the age of 18 years of age must have their parent or confirmed care giver sign the application also. Noting full name and details.</p> <p>Te Piringa Te Tuatahi and Te Ao Whānui Te Tuatoru Fund Only Tier 4 non government agencies and collectives of taitamariki may apply for the Te Piringa Te Tuatoru scholarship.</p> <p>Tier 3 & 4 non-government agencies can apply for the Te Ao Whānui Te Tuatoru category.</p>

**Criteria - Te Mātauranga
Te Tuatahi Scholarship**

The scholarship applicant must clearly demonstrate that the grant will be used to support their current educational pursuit. The individual must be enrolled in a New Zealand educational programme or centre of learning. The individual must be between the ages of 13 years of age and 24 years of age as at the 30 June 2020 and aspire to become strong and resilient Māori leader. The individual must be Māori and residing in an urban setting in Aotearoa New Zealand at the time of their application.

This scholarship can be to assist the applicant with their primary, secondary or tertiary education fees, course supplies or educational tools. It can be used to assist an applicant to attend a conference nationally or internationally, but this conference must be aligned to the applicant's course of study or educational programme. It can be used to assist the applicant with boarding fees if the individual is boarding at a school / kura / wharekura / college / student residence. It can also be used for school uniforms.

The applicant must clearly describe what the scholarship will be used for and provide evidence of this.

It can NOT be used for costs that are NOT associated with educational pursuits of the individual outside of an educational programme or institute that is not in Aotearoa New Zealand. The value per each successfully confirmed recipient will receive:

- Te Mātauranga Te Tuatahi \$2,000.00 (GST Inc) each

Note the applicant must only apply for the value of that grant.

<p>Criteria - Te Piringa Te Tuarua Grant and Te Ao Whānui Te Tuatoru Grant</p>	<p>The applicant must clearly demonstrate that the grant will be for innovative project/s that will support Māori taitamariki 13 years of age to 24 years of age to become strong and resilient Māori leaders.</p> <p>The applicant must be a registered non-government entity based in an urban setting in Aotearoa New Zealand at the time of the application and for the full duration of the service that the application is for. And must be financially solvent.</p> <p>Only Tier Four non-government entities may apply for a Te Piringa Te Tuarua grant. The entities must be a legally recognised organisation in Aotearoa New Zealand and must be registered on one of the several registers by the New Zealand Companies Office.</p> <p>Whereby the applicant is a collective of entities working in partnership they must clearly identify each member of that collective.</p> <p>Please note that both Tier Three and Tier Four entities may apply for Te Ao Whānui Te Tuatoru grant.</p> <p>In these two categories the value per each successfully confirmed scholarship or grant recipient will receive:</p> <ul style="list-style-type: none"> • Te Piringa Te Tuarua \$5,000.00 (GST Inc) each confirmed recipient • Te Ao Whānui Te Tuatoru \$20,000.00 (GST Inc) each confirmed recipient. <p>Note the applicant must only apply for the value of that scholarship or grant.</p>

<p>Application Process</p>	<p>All applications will be received by our administrator who will confirm with you via email receipt of your application by Wednesday 15 April 2020.</p> <p>All applications completed correctly and meet the criteria of the Fund's category that the application is being made for will be assessed by an independent panel on the Thursday 23 - Friday 24 April 2020.</p>

	<p>Applicants will be notified by the Friday 15 May 2020 of the outcome.</p>
<p>Payment</p>	<p>Te Mātauranga Te Tuatahi After the confirmation received by our office from the recipient of the acceptance arrangement, the Trust will make a one off payment to the successful applicant into bank account by Monday 20 July 2020.</p> <p>Te Piringa Te Tuarua and Te Ao Whānui Te Tuatoru After the confirmation of the recipient and the acceptance arrangement has been received by the Trust, the Trust will make an on-signing payment to the successful applicant to the account as noted in the application. Upon receipt of the completed milestone the final payment will be paid to the recipient by the Thursday 20 August 2020.</p> <p>The Trust notes that both Te Piringa Te Tuarua and Te Ao Whānui te Tuatoru will be paid in 2 instalments.</p>

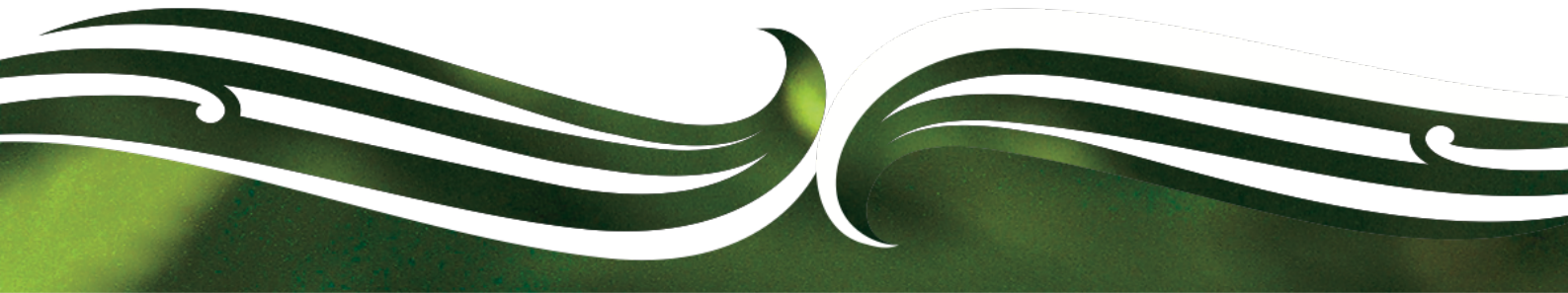

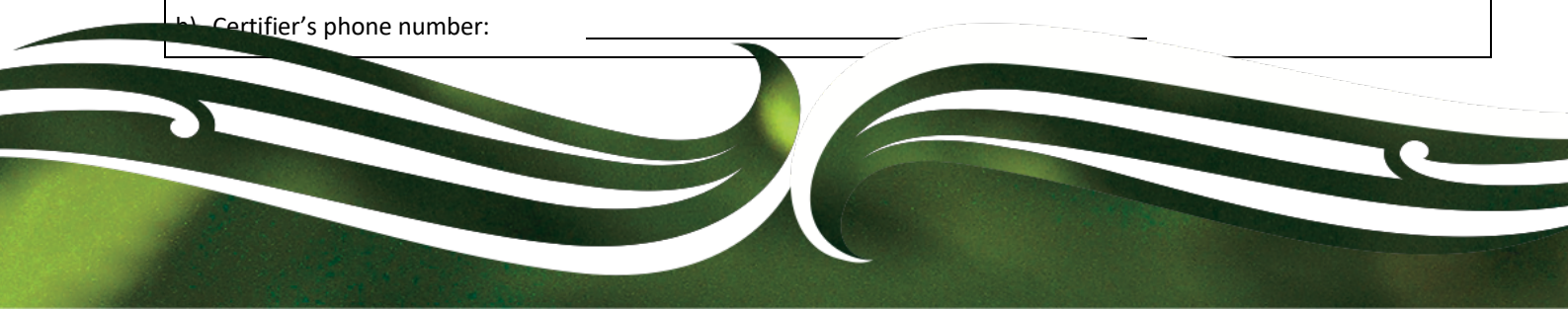
